Akraino TSC Charter Update

- Review proposed language in Section 2.C of the TSC Charter
- Current language:
 - The TSC will have up to 20 voting members. If any at point in time following the Transition Point any one organization, including its Subsidiaries (as defined below), employs more than 25% of the TSC members (“Related Company TSC Members”), then the votes of all such Related Company TSC Members will be limited to 25% of the number of TSC members, rounded down to the nearest whole number. “Subsidiaries” means any entity in which any organization owns, directly or indirectly, more than fifty percent of the voting securities or membership interests of the entity in question, excluding any such entity with respect to which such organization has announced an agreement to sell or otherwise divest its entire interest in such entity.
